#### A MESSAGE FROM THE PRESIDENT

Dear Members,



AMACS is an ongoing project that now involves over eight hundred members. It remains the driving force for positive change in all aspects of firearms collection and sports shooting. AMACS has been responsible for proposing, drafting and improving arms legislation. Moreover we have set higher standards in the way our members approach their sports and hobby.

2013 has been an extraordinary year. In February we saw the introduction of improvements to legislation in the form of Legal Notices 75 and 76. These were the result of several months of hard work and lobbying in the Weapons Board.

However over the past months we have witnessed the introduction of several Police measures aimed at limiting and, in some cases, reversing the gains that were attained in February. The newly-constituted Weapons Board is doing its part in defending the provisions of Legal Notice 75.

AMACS will continue to defend the gains that were made for the good of the entire shooting and collecting community while always showing a disposition for considering the authorities' proposals for improvements. After all we have always embraced change and used it as an occasion to renew ourselves. Thankfully our administration harbours a positive mindset.

AMACS firmly believes that the community's interests are best served if all shooting and collecting organisations coordinate their effort and, in a spirit of solidarity, present the authorities with common proposals. I am sure that this is what the authorities expect of us. A perfect occasion presented itself to us when the Parliamentary Secretary for Sports, Hon. Stefan Buontempo, invited all organisations to present their proposals for a national range project. AMACS wrote to AACTS and MSSF proposing that a meeting between the three would be held prior to meeting the Parliamentary Secretary. Unfortunately this proposal was turned down.

However the organisations' discussion with Dr. Buontempo was kept on track and there is a positive feeling that the common aim for the establishment of a range complex will bind us

together and make it simpler for the authorities to help us get there. AMACS has already contributed its know-how to the project and will continue to do so to ensure that our dream is realised. This is now the prime objective for 2014.

Moreover, during this meeting with Dr. Buontempo, all the organisations spoke in defence of the Legal Notices that were published last February. This common position was certainly not lost on the Parliamentary Secretary and we are sure that he is playing a part in defending our position.

Another objective that we want to reach in 2014 is the Tigne' 10m range and exhibition hall project. Much effort has been put into this project by the Secretary and Treasurer in order to acquire MEPA permits as well as substantial funding towards the project's realisation. Positive results are expected in early 2014.

Participation in sports shooting events organised by IPSC Regional Director Clive Brockdorff as well as the pin shooting events organised by Christopher Vella continues at a steady pace. A calendar of sporting and cultural events is being prepared for 2014.

I take the opportunity to wish you and you loved ones a peaceful Christmas and a Happy New Year.

Kick also served as honorary member, co-founder and former chairman of NVBIW Edouard de Beaumont. He was a Knight of the Order of Orange-Nassau. AMACS was accepted as a FESAC affiliate during Kick's tenure as Chairman in 2006. It was he who later expressed his wish that I should lead FESAC and proposed me for the post of Chairman. He was my mentor and guide in my initial years at the helm and continued to offer his support and advice till the end. Farewell my friend – you will be missed.

#### NEWS FROM BRUSSELS - DG HOME WANTS TO REOPEN THE ARMS DIRECTIVE

The Commission's Home Affairs Directorate General has launched a strong bid to amend the existing Firearms Directive and make far-reaching changes. They have gone as far as quoting unfounded figures (such as the notorious half a million firearms that have been-diverted from legal ownership to the black market – what they are not saying is that the majority were from Government-controlled stocks!) as a pretext. They have also ignored the overwhelming majority (80% +) that responded negatively to a questionnaire that they themselves commissioned.

FESAC coordinates its EU policies and actions through the European Sports Shooting Forum (ESSF) that brings together sports shooters, collectors, hunters, industry and trade. The ESSF issued its Common Position paper last June and distributed it to EU and national officials. The forum partners that collectively represent over ten million responsible and law-abiding citizens strongly oppose the reopening of the Directive, stating that what is required is proper enforcement at Member State level.

On 21 October DG Home issued a communication entitled "Firearms and the internal security of the EU: protecting citizens and disrupting illegal trafficking". It will now be circulated among Member States for their approval. Malta has to state its opinion; we must lobby our leaders to take a similar position as the German Federal Council (Bundesrat) which adopted a resolution expressing doubts exist concerning the Commission's proposal in view of the conservation of the Principles of Subsidiarity (art. 5, para. 3 European Union Treaty) and Proportionality (art. 5, para. 4 European Union Treaty). It adds that "The maintenance of public security and order as well as the protection of internal security involves the Member States' office (art. 72 of the Treaty on the Functioning of the European Union) and remain in their sole responsibility (art. 4, para. 2, phr. 3 European Union Treaty)."

Enthusiasts often fall into the trap of ignoring what is happening in the world around them. As sports shooters and arms collectors we have no option but to be well-informed and well prepared. Do not delude yourselves that we live in isolated bliss. You first line of defence is in the EU where FESAC keeps a constant watch.

I am happy to say that IPSC is probably one of the fastest-growing disciplines in Malta and that the feedback from those who join us (from all clubs) is always very positive.

From the records we keep, we can see that the number of regular shooters has grown, as have the skill levels of the participants. We held a series of well-attended events, both in
